On or about March 10, 2022 the above-named Responsible Entity (RE) received funds from Washington State Department of Commerce (Commerce) under Title I of the Housing and Community Development Act of 1974 (PL 93-383) for the following project:

Purpose and Nature of the Project: To expand and upgrade the heating, ventilation, and air conditioning (HVAC) systems in North Valley Hospital.

Estimated Cost of the Project: \$2.8 million, \$764,271.00 of which will come from this grant.

The activities proposed are categorically excluded under HUD regulations at 24 CFR Part 58 from National Environmental Policy Act requirements. As of the publication of this notice, no grant funds have been expended.
