**North Valley Hospital District
Legal Description – August 2, 2022**

Commission District 1

Starting at the intersection of northern border of the hospital district and the Windy Peak Trail 342.

Meandering southerly on the Windy Peak Trail 342 to the southern border of Section 33, Township 40, Range 23E.

East on 18.25 miles, more or less to the southeast corner of Section 33, Township 40, Range 26E.

South 2 miles to the southwest corner of Section 10, Township 39, Range 26E.

East 1 mile to the southeast corner of said section.

South 1 mile the southwest corner of Section 14, Township 39, Range 26E.

East 0.75 miles, more or less to Wannacut Lake Rd.

South 1 mile the southern boundary of Section 23, Township 39, Range 26E.

East 2.25 miles, more or less, to the northwest corner of Section 29, Township 39, Range 27E.

South 1 mile the southwest corner of said section.

East 1 mile to the southeast corner of said section.

South 1 mile to the southwest corner of Section 33, Township 39, Range 26E.

East 1.25 mile, more or less to Hwy 7.

Northerly on Hwy 7 to the 2020 Census city limits for Oroville.

Counter-clockwise on the 2020 Census city limits for Oroville to the intersection of 3rd Ave, Golden St, and Moonlight Dr.

North on Golden St to 5th Ave.

East on 5th Ave to US Hwy 97.

Southeast on US Hwy 97 to the Cascade and Columbia River Railroad.

Northerly on the Cascade and Columbia River Railroad to the northern boundary of Section 34, Township 40, Range 27E.

East 4.40 miles, more or less, to the northwestern corner of Section 33, Township 40, Range 28E.

South 6 miles to the southwest corner of Section 21, Township 39, Range 28E.

East 7 miles to the northwest corner of Section 27, Township 39, Range 29E.

South 1 mile to the southwest corner of said section.

East 5 miles to the northwest corner of Section 33, Township 39, Range 30E.

South 1 mile to the southwest corner of said section.

East 7 miles to the northwest corner of Section 03, Township 38, Range 31E.

South 1 mile to the southwest corner of said section.

East 3 miles to the northeast corner of Section 12, Township 38, Range 31E and the hospital district boundary.

Counter-clockwise on the hospital district boundary to the point of the beginning.

Commission District 2

Starting at the intersection of hospital district and the northeast corner of Section 01, Township 36, Range 31E.

West 10.50 miles, more or less, to the southeast corner of Section 36, Township 37, Range 29E.

North 3.75 miles, more or less, to State Route 20.

Meandering westerly on State Route 20 to the southern border of Section 23, Township 37, Range 27E.

West 3.12 miles, more or less, to the Okanogan River.

Meandering upstream, northerly, through the Okanogan River to eastern extension of the southern east/west part of River Loop Rd.

West on the extension and the southern east/west part of River Loop Rd to Hwy 7.

Meandering northerly on Hwy 7 to

the 2020 Census city limits for Oroville.

Counter-clockwise on the 2020 Census city limits for Oroville to the intersection of 3rd Ave, Golden St, and Moonlight Dr.

North on Golden St to 5th Ave.

East on 5th Ave to US Hwy 97.

Southeast on US Hwy 97 to the Cascade and Columbia River Railroad.

Northerly on the Cascade and Columbia River Railroad to the northern boundary of Section 34, Township 40, Range 27E.

East 4.40 miles, more or less, to the northwestern corner of Section 33, Township 40, Range 28E.

South 6 miles to the southwest corner of Section 21, Township 39, Range 28E.

East 7 miles to the northwest corner of Section 27, Township 39, Range 29E.

South 1 mile to the southwest corner of said section.

East 5 miles to the northwest corner of Section 33, Township 39, Range 30E.

South 1 mile to the southwest corner of said section.

East 7 miles to the northwest corner of Section 03, Township 38, Range 31E.

South 1 mile to the southwest corner of said section.

East 3 miles to the northeast corner of Section 12, Township 38, Range 31E and the hospital district boundary.

Clockwise on the hospital district boundary to the point of the beginning.

Commission District 3

Starting at the intersection of hospital district and the northeast corner of Section 01, Township 36, Range 31E.

West 10.50 miles, more or less, to the southeast corner of Section 36, Township 37, Range 29E.

North 3.75 miles, more or less, to State Route 20.

Meandering westerly on State Route 20 to the southern border of Section 23, Township 37, Range 27E.

West 3.12 miles, more or less, to the Okanogan River.

Meandering upstream, northerly, through the Okanogan River to eastern extension of the southern east/west part of River Loop Rd.

West on the extension and the southern east/west part of River Loop Rd to Hwy 7.

Meandering northerly on Hwy 7 to the southern border of Section 34, Township 39, Range 27E.

West 1.25 miles, more or less the southeast corner of Section 32, Township 39, Range 27E.

North 1 mile to the northeast corner of said section.

West 1 mile the northwest corner of said section.

North 1 mile to the northeast corner of Section 30, Township 39, Range 27E.

West 2.25 mile to the southwest corner of the southeast quarter of the southeast quarter section of Section 23, Township 39, Range 26E.

North 1 mile to the northern border of said section and Wannacut Lake Rd.

West 0.75 miles to the southeast corner of Section 15, Township 39, Range 26E.

North 1 mile to the northeast corner of said section.

West 1 Mile to the northwest corner of said section.

North 2 miles to the northeast corner of Section 04, Township 39, Range 26E.

West 18.25 miles, more or less, to Windy Peak Trail 342.

Meandering northerly on Windy Peak Trail 342 to the hospital district boundary.

Counter-clockwise on the hospital district boundary to the point of the beginning.
